² Postdoctoral fellowship are eligible to submit as PD/PI if the fellowship solicitation limits eligibility to postdoctoral researchers. Please note that a mentor should be included on the Proposal Development document to oversee the project if awarded.

³ An Other Significant Contributor (OSC) is an individual that does not commit measurable effort toward the project and is not paid.

⁴ HFH employees, with or without an MSU appointment, named as a Consultant on a project must be budgeted with salary plus fringe for their effort devoted to the project.

⁵ New key personnel added during an award period must provide a biographical sketch, other support, and devoted effort for the RPPR. New OSCs added during an award period must provide a biographical sketch for the RPPR.
